A Resolution Regarding Snelling Dining Hours

WHEREAS, students utilize Snelling Dining Commons to study late-night before exams; and,

WHEREAS, Snelling Dining Commons is the only dining hall at the University of Georgia to operate overnight; and,

WHEREAS, Snelling Dining Commons is operating and open to students from "Mondays at 7:00 AM for continuous service until 2:30 PM on Fridays;" and,

WHEREAS, 24,455 students were scheduled to take a final exam for the spring 2018 semester on Monday, April 30th, 2018;² and,

WHEREAS, 27,320 students were scheduled to take a final exam for the fall 2018 semester on Monday, December 10th, 2018;³ and,

WHEREAS, 24,247 students are scheduled to take a final exam for the spring 2019 semester on Monday, May 6th, 2019;⁴ and,

WHEREAS, the Student Government Association would like to thank the University of Georgia Dinings Services for its collaboration to begin opening Snelling Dining Commons at 12:00 AM every Monday during finals week in order to allow students to study there late-night prior to their examinations.
